HOW TO WRITE REFERENCES IN YOUR THESIS

It is very well known the writing the references in the thesis is usually according to the Vancouver system of references. However, the Vancouver system itself has multiple styles and if the post-graduate student writes the reference by copying it from the online journals and pasting it to the theses; he(she) will be a victim of wrong referencing as each journal have its style and already lists the references according to the Vancouver style that was selected by the journal editorials and even some journals depend on another system of referencing rather than Vancouver; so post-graduate students will have multiple styles or even multiple systems of referencing in one thesis which is usually wrong.

I recommend the last style "Vancouver (superscript)" as it is summarized, includes most of the information needed and is used by most of the well-known journals

TYPES OF CITATIONS :

- Journal Reference
- Book Reference (book or a chapter of a book)
- Internet Reference (website or accepted paper for publications)

Journal reference

- Authors (use et al. after 6 authors, if there are more than six authors, complete names should not be written.- write last name and the first character of the first name and middle name if present followed by a dot, "et al" must be in italics)
- Article title (should be exact as existing)
- Journal name (should be in standard PubMed abbreviations, full journal name should not be written – you can find journal name abbreviation by writing the journal full name in this link: https://www.ncbi.nlm.nih.gov/nlmcatalog/journals/)
- Year
- Volume
- Issue (between brackets)
- Page numbers (445-447 to be written as 445-7)

- 4. Full stop at the end of the reference.

- Editors (use et al. after 6 authors, if there are more than six authors, complete names should not be written.- write last name and the first character of the first name and middle name if present followed by a dot, "et al" must be in italics)
- book title (should be exact as existing)
- edition
- volume _ if present
- publisher name
- Year
- Page number (445-447 to be written as p.445-7)

Notes:

- 1. Semicolon; after the year without any space

- Authors of the chapter (use et al. after 6 authors, if there are more than six authors, complete names should not be written.- write last name and the first character of the first name and middle name if present followed by a dot, "et al" must be in italics)
- Chapter title (should be exact as existing)
- In:
- Chief Editors
- book title (should be exact as existing)
- edition
- volume
- publisher name
- Year
- Page number (445-447 to be written as p.445-7)

web site Reference : (I strongly discourage you to cite from websites *)

- Author / Organisation. (usually web sites are related to organizations rather than authors)
- Title site. (the main title of the website)
- Internet.
- Place of publication:
- Publisher;
- [updated year month date (last update of the website); cited year month date (the date you visited the website and performed your citation as an author)].
- Available from: URL.

*I strongly discourage you to cite from a website as the sites may be related to a commercial or nonscientific organization or it may already showing up published materials that should be cited in the formal way (like researches or books)

Manuscript accepted for publication Reference : (better to be avoided^)

- Authors (use et al. after 6 authors, if there are more than six authors, complete names should not be written.- write last name and the first character of the first name and middle name if present followed by a dot, "et al" must be in italics)
- Article title (should be exact as existing)
- Journal name (should be in standard PubMed abbreviations, full journal name should not be written – you can find journal name abbreviation by writing the journal full name in this link : https://www.ncbi.nlm.nih.gov/nlmcatalog/journals/)
- ISSN number
- Link to the manuscript

^ better to be avoided as you may cite it correctly in your theses then after months when the reviewer comes across your theses and check this reference; he (she) may find it already published and it will be a negative point on your theses which is not due to a real mistake

Recommendations:

- 1. Use Vancouver system for referencing and use Vancouver superscript style
- 2. Better to avoid citation unpublished articles or thesis as you will be confused of how to write a reference – like a journal article or a book or how ??
- 3. Better to avoid citation of a websites see details above
- Better to avoid citation of a manuscripts that are accepted for publication in a journal but not yet assigned to a specific volume or issue of that journal – see details above
- 5. Try to cite recent manuscripts not older than the last 10 years
- 6. Try to cite manuscripts published in a well-known international journals with high impact factor
